


How to access your **Canada Child Benefit (CCB) Notice**

1. [Log into CRA My Account](#) from a desktop computer (*PDFs may not generate properly if logged in from a mobile device*)
2. Click **Mail** 
3. Filter Mail by **Tax Year**, select **2024**. 
4. Look for your **most recent CCB notice (base year 2024)** and click "**Open**". 
5. Click "**PDF**".  Click "**Print/Save**".
6. This will generate your **CCB Notice as a PDF** to download and save a copy to your computer.
7. Either **attach the CCB Notice** to your *online* or *webform* KidSport Edmonton grant application or attach it to an email and send with your completed *paper* application and sport receipt to edmonton@kidsport.ab.ca.
